- 1) All materials are lying at the working site of Duma sluice site Bidyadhari Drainage Sub-Division Batamore Bongaon. The interested bidders may see the materials as referred above prior to quote their rates as the table given above.
- 2) Before participating in the bid call, the intending bidders should make themselves acquainted thoroughly with the local conditions prevailing by actual inspection of the materials and take into considerations all factors and difficulties likely to be involved in all aspects including transportation of materials, communication facilities, availability of local labors and market rate prevailing in the locality etc. as no objection or claim whatsoever will be entertained on these accounts afterwards i.e., at the conclusion of the auction.
- 3) The intending bidders having PAN, AADHAAR CARD, VOTTER CARD etc. should possess sound financial capacity including adequate experience in performing the works of similar nature have to produce all documents with quotation paper in their letter heads and an Accepted and Self Signed Auction notice (Auction notice will be supplied from S.D.O/ BDSD one hour prior to the submission of bid) in a sealed Cover to the office of the undersigned within 15-11-17x upto x.12.00 P.M. and the rates quoted by the bidders will be opened on the same day at 1.30 P.M. in the office of the undersigned in presence of the bidders those who will be present at that time. Attendance register may be signed prior to dropping of bids. Subsequent upon the opening of the sealed bids, if found less than the sanctioned rate (which is considered as reserved value/ face value) the seal bids shall be followed by open bid with a reveal of reserved value/face value. Hence, all the bidders have to be present during opening of sealed bids as well as have a preparation for conducting open bids.
  - 4) The Accepting Authority may refuse to accept the offer of the highest bidder and his decision to do so shall not be open to question. It is the discretionary power of the competent authority to accept or reject any of the bid offered. The bidders will not be entitled to question or review upon the discretionary power.

- 5) Any illegible bid is liable to be rejected. All the bidders should quote their rates both in figures and words. The Sub-Divisional Offficer Bidyadhayy Drainage Sub-Division, Bongaon / Executive Engineer, Bidyadhari Drainage Division, Taki Road, Barasat reserves the right to reject any or all the bids without assigning any reason thereof. Bid of highest bidder will be accepted if his bid is above the sanctioned rate (which is considered as reserved value/ face value) which will be disclosed after sealed bid.
- 6) All the bidders have to deposit an amount of Rs. 1900.00(Rupees one thousand nine hundred) only as Earnest Money along with the sealed bids which will be refunded after the Auction is over excepting the successful bidder. For successful bidder this amount will be adjusted with the final amount to be paid.
- 7) An acceptance cum work order will be issued to the successful bidder from the undersigned.
- 8) The successful bidder whose rate will be accepted by the competent authority is liable to deposit entire bid amount in the office of the undersigned through Demand Draft (CTS) in favor of "EXECUTIVE ENGINEER, Bidyadhari Drainage Division" or cash, within next 3 (three) working days positively, from the date of issuing work order, otherwise lifting of materials will not be allowed and in that case earnest money deposited shall be forfeited.
- 9 The lifting of materials should be completed within 7 (seven) days from the date to be mentioned in the work-order by the successful bidder to whom the work would be assigned following condition no 08.
