Terms and Conditions in respect of N.I.Q. No.-06(m) of 2017-18 of Executive Engineer, Cooch Behar Irrigation Division.

- 1) The vehicle should be in tip top running condition having commercial registration.
- 2) The owner of the vehicle will provide driver (With valid Driving Licence) with the vehicle, with sound health & eyesight & should possesses a good moral quality. Certificate of health, eyesight & moral quality of the driver issued by the appropriate authority should be produced before placing the vehicle.
- 3) The owner of the vehicles as well as driver should have a mobile phone facility, in order to make the optimum use of the vehicle.
- 4) Fuel consumption maximum @ 12kms/per litre Diesel & Mobil Oil @1(one) litre per 500kms. will be considered during calculation of consumption .
- 5) The Owner will be responsible for up-keeping of vehicle including maintenance & repairs as required including supply of spare parts and no additional cost for this purpose will be entertained by this department.
- 6) Lowest quotationer will have to deposit a bank draft amounting to Rs.1000.00 (Rupees one thousand) only drawn in favour of the "Executive Engineer, Cooch Behar Irrigation Division" drawn from any nationalized bank.
- 7) The lowest quotationer will have to put his vehicle to the undersigned for a test within 3(Three) days from the date of intimation for such placement otherwise his quotation will be inoperative and it treated to be cancelled.
- 8) The agreement shall remain valid for 1(one) year from the date of acceptance and may be it extended for further one year under discretion of the quotation accepting authority.
- 9) The agreement may be terminated within the contractual period with 1 (one) months notice from either side.
- 10) The hiring of vehicle will be on daily basis. The rate of hire charges should be quoted on daily basis both in figures and word. The cost of hire charge will be paid monthly on production of bill by the owner.
- 11) Any discrepancies/conditional rate/over written on the quoted rate will lead to rejection of the quotation without any further correspondence.
- 12) The vehicle will normally not be required, on any Govt. holidays, but if necessary the vehicle has to be placed for which advance intimation will be given and no extra cost will be provided for that duty.
- 13) The rate Quoted will be inclusive of all taxes, maintenance and running cost etc. No other charges & extra cost will be entertained.
- 14)Attested Xerox copies of certificates for PAN, GST, Professional Tax, Road tax, Insurance, Certificate of registration, Pollution certification and driving Licence etc. submitted will be verified from original at time of formal agreement.
- 14) Maximum 10 (ten) kilometres of Journey will be allowed between garage of the vehicle and the place of reporting (both way inclusive). (as per Govt. norms).
- 15) Replacement of the car should not be entertained normally and it will be entertained only in case of maintenance of the car and replacement should be done by a good vehicle only of compatible quality & only having valid documents.
- 16) Once agreement has been finalized the car should not be placed to any other Deptt. or office which will lead to cancellation of the agreement.

17) The quotation accepting authority has every right to cancel, reject of any Quotation without showing any reasons thereof.
