Quotation in prescribed proforma invited by the Sub-Divisional Officer, Burdwan Irrigation Sub-Division No. IV, Kalna, Purba Bardhaman from the Agencies/Organizations, Contractors and General order suppliers having similar working experience in connection with the following work:-

Name of Work:- Hydrographic Survey / Cross section survey as per requirement on River Bhagirathi under Burdwan Irrigation Sub-Division No. IV, Kalna, Purba Bardhaman.

The intending bidders having valid licenses, PTPC & ITR, PAN, GST registration etc. should possess adequate experiences in the field of detail topographical survey for enabling the requirement of Engineering Department and other related Departments who deal with details information of the areas in respect of political, geographical, topographical, demarcation of boundary, water bodies, roads, railways buildings, hutments, rivers, canals, drainage channels, bridge, culverts and all other requisite information to have detail idea of the areas. Any additional input, if felt necessary by the department, is to be surveyed, incorporated and shown in the survey map to be handed over by the agency to the department. No additional expenditure in this connection will be borne by the department.

Prior to furnishing the survey map, the lowest bidders should get well acquainted with his assignment in detail discussions with the Engineer-in charge or his authorized representative to avoid submission of any incomplete survey map which is liable to be rejected. The Engineer-incharge reserves the right in this regard to reject any/all incomplete (in terms of requirement of the department) survey drawing without assigning any reason thereof. The lowest bidder is liable to rectify any error/omission dected by the department at his own cost. No claim what so ever in this regard from the bidders will be entertained. The documents to be supplied in quadruplicate both in hard and soft copies. The decision of the Engineer-in-charge is final and binding.

Scope of Work:-

HYDROGRAPHICS survey (Method:- Acoustic Doppler Current Profiler) of the river Bhagirathi for a length of 1000 m along the river and bank to bank across the river.

- 1) Cross section sheet at least 30m interval or less showing the variation depth with length across the river both in same scale i.e. equal Vertical and Horizontal scale.
- 2) Contour sheet, Topographical sheet.
- 3) All soft copy of format.

The area proposed to be surveyed should be seen and made necessary reconnaissance of by the lowest bidder with the departmental representative. Any part area/patch of area relevant to the whole survey, if not reflected inadvertently, is to be surveyed by the bidder at his own cost.

The total survey work including submission of requisite map in quadruplicate both in hard and soft copies separately for each item mentioned in the scope of the work of the N.I.Q. is to be executed

whitin 20 (Twenty) days from the date of issue of the work order. Finalisation of drawing as stated above will rest upon the discretion of the Engineer-in-charge, no claim what so ever in this regard will be entertained.

The quotation is to be submitted in the following format. Any incomplete/illegible quotation is liable to be rejected. For evaluation of lowest bidder the total amount will be considered.

After having the work order and prior to under take the jobs, the successful bidder will have to execute formal agreement in W.B. Form No.- 2911 by depositing 2% (Two percent) of amount quoted as Earnest Monay through bank Draft drawn in favour of the "EXECUTIVE ENGINEER-II, DAMODAR CANAL DIVISION" within 7 (Seven) days from the date of issue of the work order failing which the work order may be treated as cancelled.
