- Any corrigendum notice that may be issued in connection with this NIQ shall also form part of the agreement of contract.
- Bidder / quotationer who will sign on behalf of the manufacturer's / company or firm, must produce the authenticate documents in support of his competency under the Indian Partnership Act, failing which all the papers in his favour will be treated as cancelled.
- Conditional bid / quotation, which does not fulfill any of the above conditions, and is incomplete in any respect, is liable to be summarily rejected.


