Instructions given by the Sub-Divisional Officer/Assistant Engineer and the Junior Engineer/Section Officer (SO) on behalf of the Engineer-in-Charge shall also be valid (who have been authorized to carry out the work on behalf of the Engineer-in-Charge) regarding specifications and work, the decision of Engineer-in-Charge shall be final and binding. The Engineer-in-Charge will however take all decisions relating to works contract only after recommendation/ advice of the Tender Accepting Authority. - 2. - 2) The DG SET must have valid papers to commission on Govt office complex.
- 3) The DG SET should be in good condition as regards to body and engine with necessary accessories and to be provided with an **efficient** operator having sufficient knowledge to run the machine. The wages and allowance of the operator will have to be paid by the contractor including overtime allowance if necessary. The DG SET should be branded.
- 4) Normal hours of operation will be as per requirement and on availability of power. The DG SET may also run on holidays as per requirement of officers. Office and street light will have to be illuminated as per requirement.
