- 3) The successful quotationer will have to execute formal agreement in W.B. Form 2911 as the case may be with Earnest Money @ 2 % of total value of quotation as per rules in the shape of Bank Draft in favour of the **“Executive Engineer, Burdwan Irrigation Division”** within 7 (Seven) days from the date of issue of the work order failing which the work order may be treated as cancelled.
