i) Professional tax enrollment certificate ii) PT clearance certificates iii) GSTIN iv) Trade registration certificate v) PAN vi) latest IT return

Note: Above documents should be valid at least up to the date of opening of the quotation. Application for such clearance addressed to the competent authority, subject to production of authenticated receipt, may also be considered.

04. Quotation will be liable to rejection if names of the makes & full specification are not given. The acceptance of the quotation will be made by the Executive Engineer, Mechanical & Electrical Division, Midnapore, Khasjungle, P.O-Abas, District- Paschim medinipur, who does not bind himself to accept the lowest quotation and reserves to himself the authority to reject any or all of the quotations received if any discrepancy is found and in case of equal rate quoted by more than one quotationers for the same work a bid call will be invited after opening.

05. The intending quotationers should thoroughly acquaints himself with the proposed work and all other relevant factors should be taken into consideration before quoting rates as no claims whatsoever will be entertained after words.

06. Work should be completed within 10 days from the date of issuance of work order.

07. TDS on GST and IT will be deducted from the bill to be paid by the contractors as per rule.

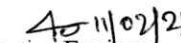
08. Cess @ 1% will be deducted from the bills to be paid to the contractors under the Building and construction works welfare cess Rule-2004

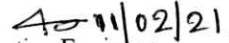

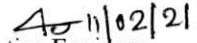
