- 3. The department shall not have any liability arising out of any accident while the vehicle is in use by the department whether or not the accident was caused due to negligence of the Driver. The department shall not be liable to pay any damage / consumption to the quotationer or any other person who may be affected by the accident.
- 5. Extension of the validity of the contract with the quotationer beyond the expiry of contract period at the same terms and conditions and rate under mutual agreement by both the sides.
